



## **PRIVACY POLICY**

Welcome to the Clinkomatic.com website (the “Website”). This Website is operated by Clinkomatic, brand of Francesco Altomare – Hasenheide, 9 – 10967 Berlin – Germany – IČ DPH: DE288729704

Clinkomatic takes your privacy seriously. Please read the following to learn more about our privacy policy. The federal government and technology industry have developed practical tips to help you guard against Internet fraud, secure your computer and protect your personal information. Clinkomatic strives to keep all of our terms, including our privacy policy, to be as simple as possible. Clinkomatic collects information to customize the content you see, fulfill your requests for products and services, improve our services, contact you and for other reasons. Clinkomatic also allows its users to create profiles on the Clinkomatic service. Clinkomatic collects two types of information:

### **Information We Explicitly Request**

In order to sign up for a Clinkomatic account and use the service, we require some simple information like a name, email address and/or account authorization via Facebook, Twitter, YouTube, etc. When you enter this information, Clinkomatic stores it so your account may persist, and to help us keep a record of your activities on the service.

Additionally, Clinkomatic may request and collect financial information including tax ID or other information necessary to receive or render payment for advertising services or other services.

### **Information Provided From the Use of Our Service**

Occasionally Clinkomatic will collect certain kinds of information about how/when you use the service, like when you visit a link generated by the Clinkomatic service, or post an ad to a social media account. This information includes:

- Log Information - This can include details of how you used the service/arrived at the service, your IP address, and cookies which may uniquely identify your account or browser.

- Device Information - In order to better serve our customers, Clinkomatic occasionally collects data about the types of devices which access our service, including hardware models, operating system versions, unique device identification and mobile network information, including phone numbers.
- Location Information - When you access the Clinkomatic service from a device, or connect a location-aware social media account, Clinkomatic may store location information in order to better serve our users and customers
- Local storage - We may collect and store information - including personally identifiable information - locally on your device, using cookies, browser web storage, and application data caches, among other sources

### **Information that do not require your consent**

Clinkomatic, in its capacity as owner of the processing of personal data, informs you that the personal data you provide may be used for:

- c. fulfilling obligations provided for the law regulations or Community legislation;
- d. the management of any claims and / or disputes.

### **Method of treatment**

The processing shall be done as by the help of automated instruments, as by paper. For the processing of personal data Clinkomatic will make use of Responsible and Trustees of treatment identified in the areas of reference technical, commercial and administrative support. Some processing operations technical or organizational or management, to supply the services of the site Clinkomatic may be carried out by third party companies nominated Trustees of treatment of Clinkomatic. Clinkomatic also specifies that it may use automatic collection of information about the user such as web beacons and cookies for the sole purpose of making easier the use of services.

### **Data Communication**

With reference to the above points, the data collected may be disclosed to third party companies operating both in EU and non-EU or transferred abroad to take full advantage of the services requested. The data collected will be disseminated as part of the services required and may be viewed by all registered users Clinkomatic.

### **Clinkomatic's rights**

Clinkomatic can manipulate the data as well as any additional information relating to the user when it believes in good faith that such activities be necessary to protect the

interests of Clinkomatic and / or third parties; Clinkomatic will also comply with requirements of the law or measures of any competent authority, support the competent police authorities in the suppression of illicit activities put in place via Internet from one or more users also but not necessarily in the use of services and / or in case of the use of services has been in any way instrumental to the commission of any type of crime; assert its rights at any location, status, rank, and against anyone; defend itself from any third party disputes that argue that any actions and / or omissions in every way being by the User through the services and / or result of the use of the services, violates their rights. **Information Sharing**

Clinkomatic does not rent, sell, or share personal information about you with other people or non-affiliated companies except to provide products or services you've requested, when we have your permission, or when we respond to subpoenas, court orders, or legal process, or to establish or exercise our legal rights or defend against legal claims. If Clinkomatic becomes involved in a merger, acquisition, or any form of sale of some or all of its assets, we will provide notice before personal information is transferred and becomes subject to a different privacy policy.

Clinkomatic may combine information we obtain from business partners or other companies, such as our social media partners, with information Clinkomatic has collected about you in order to serve you better or optimize the functions of the Service.

## **Cookies**

Clinkomatic may set and access Clinkomatic cookies on your computer. Clinkomatic uses these cookies in connection with Clinkomatic products and services.

## **Contents of Items**

The contents of any item that you post directly to the Site, including any text, images, photos, videos and audio, are stored and maintained on our servers in order to publish these items and provide the Service. Your submitted content will be associated with your account.

## **Confidentiality and Security**

We limit access to personal information about you to employees or third-party agents who we believe reasonably need to come into contact with that information to provide products or services to you or in order to do their jobs. These individuals are bound by confidentiality obligations and may be subject to discipline, including termination and criminal prosecution, if they fail to meet these obligations.

## **Third Party Sites**

This Policy only applies to the Clinkomatic website and services. We do not exercise control over the sites that our service links to. These other sites may place their own
